FEBRUARY 2017 ANNUAL MEETING MINUTES

February 15, 2017 Greenbriar East E. S. Art Room

Attendees: Karen Myers; Peter Bayer; Kerry Dangerfield, Jeff McCurry, Karen Sparks, Mike Ebert, Kevin Corcoran, David Blahuda, Jane Hicks

- Call to Order Meeting called to order at 7:02pm
- Opening Remarks Karen Myers welcomed Greenbriar Pool members to the meeting. She declared that the 2016 season was a generally successful one and described the improvements that had been, or soon will be, undertaken to improve the pool for 2017. These include installation of a new white coat in both pools, parking lot repairs, replacement of lounge chair backs and cushions, the installation of new lights in the lot and on the pool deck the replacement of the pool house roof.
- Approval of 2016 Annual Meeting Minutes Unanimously approved as presented
- Financial Report Treasurer Jeff McCurry presented the 2017 budget; expenses are projected higher than usual due to the installation of the white coat and the parking lot improvements. Both projects will reap benefits to the pool, with electric use reductions causing the lights to pay for themselves in approximately two years
- Directors' Reports
 - Vice President: The pool switched insurance companies; better coverage at lower cost
 - **Secretary:** 47 memberships were sold in 2016; average price was \$1,698, with high price of \$3,029 sold on eBay. Two memberships reverted to the pool.
 - Swim & Dive: Both teams had successful seasons. 142 swimmers, 28 divers (a new high) and 10 dual swim/dive.
 - Operations & Maintenance: Recognized Gene Nivera's long service to pool as O&M chair. Reported on new white coat, LED lights for lot and pool deck, and replacement of the pool house roof.
 - **Communications:** Demonstrated software for TV monitor installed in the lobby to track attendance and better manage swimmer load.
 - Special Events: We held lots of good events last year, but need more volunteers to sponsor or monitor events in 2017.
- **Bylaws Amendments:** The members approved three of bylaws amendments. These permitted any officer of the Board to sign contracts, changed the way the pool sells memberships that revert due to non-payment of membership fees, and changed the date on which membership fees are due.
- **Election of Officers:** There were six Board positions open for election, with five candidates nominated for office (Jeff McCurry, Karen Sparks, David Blahuta, Peter Bayer and Kevin Corcoran). All five were elected by unanimous acclamation.
- **New Business:** In response to a member's question, the Board clarified that Nanny Passes to the pool can be purchased for routine caregivers of pool members. These caregivers do not need to reside in the member's home to qualify.
- Adjourn: With no further business, the meeting was adjourned at 8:08pm
